ACADEMIC REGULATIONS R-17 FOR M.Tech (REGULAR)
(CHOICE BASED CREDIT SYSTEM)

Applicable for the students of M.Tech (Regular) from the Academic Year 2017 – 18

1. ELIGIBILITY CRITERIA FOR ADMISSION

The eligibility criteria for admission into the first year of M.Tech programs is in accordance with the guidelines issued by AICTE, New Delhi, A.P State Council of Higher Education or any other competent authority from time to time.

2. PROGRAMMES OFFERED (POST GRADUATE)

The following M.Tech programmes approved by AICTE, New Delhi are offered in the college.

3. AWARD OF DEGREE

A student will be declared eligible for the award of M. Tech. degree if he/she fulfils the following academic requirements:

- A student shall be declared eligible for the award of the M. Tech degree, if he/she pursues a course of study in not less than two and not more than four academic years.
- The student shall register for 72 credits and secure all the 72 credits.
- The students, who fail to fulfill all the academic requirements for the award of degree within four academic years from the year of their admission, shall forfeit their seat in M.Tech programme.
- No disciplinary action pending against the student.

4. MEDIUM OF INSTRUCTION

The medium of instruction is English in all academic activities.

5. MINIMUM INSTRUCTION DAYS

The minimum instruction days for each semester shall be 90 days.

6. CREDIT ASSIGNMENT

Each course is assigned a certain number of credits based on the following criteria:

7. SEMESTER –WISE DISTRIBUTION OF CREDITS

8. ASSESSMENT AND EVALUATION

The performance of a student in each course shall be evaluated based on Continuous Internal Evaluation (CIE) and Semester End Examination (SEE) or only Continuous Internal Evaluation.

8.1 THEORY COURSES

Each theory course is evaluated for maximum 100 marks with distribution of 40 marks for Continuous Internal Evaluation (CIE) and 60 marks for Semester End Examination (SEE).

- i) The CIE methodology for theory courses is based on two mid-term examinations, each for maximum 40 marks. Two mid-term examinations shall be conducted with syllabi from units I & II for the first and units III, IV & V for the second. The mid-term examination question paper shall be for 40 marks. Each mid-term examination shall be conducted for 120 minutes duration and students have to answer all three questions with each question having ‘either’/ ‘or’ option. However, 75% weightage for the better of the two and 25% for the other test shall be considered for awarding 40 marks.
- ii) The Semester End Examination (SEE) for theory courses requires evaluation for 60 marks. The question paper in each course for the semester end examination consists

of 5 questions, one from each unit with ‘either’ / ‘or’ option, carrying 12 marks each. The students are required to answer all 5 questions for maximum 60 marks. The duration of SEE is 180 minutes.

8.2 LABORATORY COURSES

Each Laboratory course is evaluated for maximum 100 marks with distribution of 40 marks for Continuous Internal Evaluation (CIE) and 60 marks for Semester End Examination (SEE).

i) Continuous Internal Evaluation (CIE)

The Continuous Internal Evaluation (CIE) is based on the following parameters:

ii) Semester End Examination (SEE)

The Semester End examination (SEE) for laboratory courses shall be jointly conducted by internal and external examiners for three hours duration and evaluated for 60 marks. The performance of the students shall be evaluated as per the parameters indicated below:

8.3 TECHNICAL SEMINAR

A student shall deliver a seminar on any emerging topic of his/her choice from the core technical domain. The student shall submit a duly-certified seminar report. The performance of a student in technical seminar is evaluated for 100 marks by a three-member committee constituted by the HoD. There shall be no semester end examination. The performance of a student shall be evaluated as per the parameters indicated below:

A student who fails to secure minimum 50% marks or abstains will be permitted to reappear for the same when offered next.

8.4 MINI PROJECT

A student is required to undergo a mini project of his/her choice by applying theoretical concepts to develop a practical component /element/system that includes design/ testing/ analysis. The performance of a student in mini project is evaluated for 100 marks by a three-member committee constituted by the HoD. There shall be no semester end examination. The performance of a student shall be evaluated as per the parameters indicated below:

A student who fails to secure minimum 50% marks or abstains will be permitted to reappear for the same when offered next.

8.5 INTERNSHIP

Internship must involve practical work related to systems engineering, industry practices etc. A student shall undergo internship for a period of 6 weeks continuously, scheduled immediately after completing II semester. The internship can be carried out at premier institutions/ research laboratories/industries and shall submit a report. A three member committee constituted by the HoD will evaluate based on the following parameters:

A student who fails to secure minimum 50% marks or abstains will be permitted to reappear for the same when offered next. There shall be no semester end examination.

8.6 PROJECT WORK

A student is required to undertake a project work by using the knowledge acquired by him/her during the course of study. The student is expected to design and build a complete system or subsystem on an area of interest.

- Project work shall be carried out in two phases during the III semester (Project work –Phase I) and IV semester (Project work – Phase II) respectively.
- A Project Review Committee (PRC) shall be constituted with the HoD as the chairman and two senior faculty as members to supervise the proceedings of the project work.
- A student has to submit, in consultation with project supervisor, the title, abstract and plan of action of project work to the PRC for approval.
- There shall be two reviews for Project work (Phase-I and Phase-II) and the average of the two reviews shall be considered for CIE.
- The student shall pass all the courses upto III semester to attend viva voce or defense of Project work (Phase-II). In case of unsuccessful defense of Project

work (Phase-II), the student shall reappear for viva voce subsequently as and when notified.

(a) PROJECT WORK (PHASE-I)

The Project work- Phase-I is evaluated for maximum 100 marks with distribution of 40 marks for Continuous Internal Evaluation (CIE) and 60 marks for Semester End Examination (SEE).

i) Continuous Internal Evaluation

The performance of a student shall be evaluated is based on the following parameters:

ii) Semester End Examination

The student shall make a presentation on the project work before a three-member committee consisting of external examiner, internal examiner (HoD) and a project supervisor. The performance of a student shall be evaluated is based on the following parameters:

The student shall submit an interim report on the Project work (Phase-I) carried out in III semester. A student who fails to secure minimum 50% marks or abstains will be permitted to reappear for the same within 6 weeks.

The performance of a student shall be evaluated is based on the following parameters:

A student who fails to secure minimum 50% marks or abstains will be permitted to reappear for the same when offered next.

8.7 COMPREHENSIVE VIVA VOCE (CVV)

The comprehensive viva voce is intended to assess the student's understanding of the courses studied during the course of study. The comprehensive viva voce is evaluated for 100 marks by a three - member committee constituted by the HoD. A student who fails to secure minimum 50% marks or abstains is permitted to reappear for the same when offered next. There shall be no semester end examination.

8.8 ADD-ON COURSES

Add-on courses are programme-based courses being offered to a student one each in I and II semesters. A student who registers for add- on courses shall be permitted to seek exemption for those many electives offered in the III semester so as to enable him/her to focus on the project work. Once a student registers for specific add-on courses, he/she needs to acquire credits for those courses only and there is no provision for change of courses under any circumstances. The assessment of performance of a student in add-on courses is same as that of the theory courses. The grade secured in the add-on course will be indicated along with other courses of that semester in the grade card.

9. ATTENDANCE REQUIREMENTS

- (i) A student is eligible to appear in the semester end examinations only if he/she acquires a minimum of 75% of attendance in aggregate of all the courses.
- (ii) In case of shortage of attendance, condonation up to 10 % in the aggregate will be allowed on valid medical grounds (65% and above and below 75%) in each semester by the college in accordance with the rules stipulated by the affiliating university.
- (iii) A shortage of attendance below 65% in aggregate shall not be condoned under any circumstances.
- (iv) A student whose shortage of attendance is not condoned will be detained and shall have to seek readmission into the same semester.
- (v) A student is required to submit the application along with the valid medical certificate by paying the stipulated fee towards condonation of shortage in attendance.
- (vi) If any student fulfils the attendance requirements in the present semester, he/she shall not be eligible for readmission into the same semester.

10. MINIMUM ACADEMIC REQUIREMENTS

The following academic requirements must be satisfied, in addition to the attendance requirements.

- (i) A student shall be deemed to have satisfied the minimum academic requirements if he/she has earned the credits allotted to each course and secures not less than a minimum 40% of marks exclusively at the Semester End Examination. However, the student should have secured minimum 50% of marks in both CIE and SEE put together to be eligible for passing the course.
- (ii) The student should have secured minimum 50% of marks for the courses with only CIE to be eligible for passing the course.
- (iii) A student shall be promoted to next semester, if he/she satisfies the minimum attendance requirements.
- (iv) Students who fail to earn 72 credits as indicated in the course structure within 4 academic years from the year of admission, shall forfeit their seat in M.Tech programme and admission stands cancelled.

11. **CRITERIA FOR RECOUNTING/REVALUATION/REVALUATION BY CHALLENGE**

A student, who failed or passed a theory course in SEE, is permitted for applying recounting/revaluation/revaluation by challenge.

- (i) **Recounting:** A student, who wishes to verify the total marks obtained by him/her in any theory course in SEE, can apply for recounting in response to the notification. The outcome of the recounting gets reflected in the results sheet and grade card.
- (ii) **Revaluation:** A student who wishes to apply for revaluation of a theory course in SEE can submit an application, along with the prescribed fee as per the notification issued.
 - (a) If the variation in marks of the first valuation and revaluation is $\leq 15\%$ of the total marks, then the better of the two evaluations shall be considered as the final marks.
 - (b) If the variation in marks of the first valuation and revaluation is $>15\%$ of the total marks, then there shall be a third evaluation by another examiner. The average marks of two nearer evaluations shall be taken into consideration. In case of any fractional value of marks, it can be rounded off to the next integer value.
 - (c) If a student secures a higher grade in the revaluation, that grade will be declared as the final grade, otherwise, the original grade will remain valid.
- (iii) **Revaluation by Challenge:** Challenge evaluation of any theory course in SEE shall be performed as per the following procedure:
 - a) An application for 'revaluation by challenge' needs to be submitted in the prescribed format along with the fee as per the notification issued.
 - b) The 'revaluation by challenge' will be carried out by a three-member committee comprising an external subject expert, internal subject expert and a senior faculty appointed by the head of the institution.
 - c) After the challenge evaluation, in case of an improvement in grade or a change in status i.e., fail to pass, the improved grade shall be awarded, otherwise, the previous grade will remain valid.
 - d) If the betterment in grades is more than two, the entire fee will be refunded.

12. **RE-REGISTRATION**

- Re-registration is applicable only after the completion of course of study.
- A student shall be given only one chance to re-register for a maximum of two theory courses, if the CIE marks secured is less than 50% and failed in that course for maximum of two times.

- The students shall register within 2 weeks from the commencement of the class work and shall secure the required minimum attendance.
- If a student opts for re-registration, his/her continuous internal evaluation marks and semester end examination marks obtained in the previous attempt stands cancelled.
- If a student opts for re-registration, the academic regulations under which he/she was first admitted continuous to be applicable.

13. AWARD OF LETTER GRADES

A letter grade and grade points shall be awarded to a student in each course based on his/her performance as per the grading system given below.

- A student who secures ‘F’ grade in any course shall be considered ‘Failed’ and is be required to reappear as ‘Supplementary student’ in SEE, as and when offered. In such cases, his/her CIE marks in those subjects will remain same as obtained earlier.
- A student, who is absent for any examination shall be treated as ‘Failed’.

14. COMPUTATION OF SGPA & CGPA

- **Semester Grade Point Average (SGPA)**

The performance of each student at the end of each semester is indicated in terms of SGPA. The SGPA is the ratio of sum of the product of the number of credits and the grade points scored by a student in all the courses to the sum of the number of credits of all the courses.

$$SGPA (S_i) = \Sigma (C_i \times G_i) / \Sigma C_i$$

Where C_i is the number of credits of the i^{th} course and G_i is the grade point scored by the student in the i^{th} course.

- **Cumulative Grade Point Average (CGPA)**

The CGPA is a measure of the overall cumulative performance of a student. The CGPA is calculated in the same manner taking into account all the courses undergone by a student over all the semesters of a programme.

$$CGPA = \Sigma (C_i \times S_i) / \Sigma C_i$$

Where S_i is the SGPA of the i^{th} semester and C_i is the total number of credits in that semester.

- The SGPA and CGPA is rounded off to 2 decimal points and reported in grade cards.

15. AWARD OF CLASS

After a student has satisfied the minimum requirements prescribed for completion of the programme and is eligible for the award of M.Tech degree, he/she shall be placed in one of the following three classes on a 10 point scale.

- A student shall be awarded 'First Class with Distinction' only, when he/she secures 72 credits within 2 consecutive academic years.

- Equivalent Percentage = $(\text{CGPA} - 0.75) \times 10$

16. ACADEMIC FLEXIBILITY

- A student can opt for 1 or 2 add-on courses offered in I and II semesters.
- The student registering for add-on courses shall be permitted to seek exemption from as many electives that are offered in the III semester in order to focus on the project work.
- A student shall be permitted to take up only project work either within the college or at any premier institutions/ research laboratories/industries, when he/she registers all 2 add-on-courses.

17. DISCIPLINE

- A student is required to observe discipline and decorum both inside and outside the college and not to indulge in any activity that may tarnish the prestige of the college. The head of the institution shall constitute a disciplinary committee to enquire into acts of indiscipline and notify the college about the disciplinary action taken. In case of any serious disciplinary action, which leads to suspension or dismissal, a committee shall be constituted by head of the institution for taking final decision.
- Those students who indulge in examination related malpractices shall be punished as per the scale of punishment notified by JNTUK, Kakinada (Annexure-I).
- Those students involved in the illegal acts of ragging shall be punished as per the provisions of Act 26, 1997 of Govt. of Andhra Pradesh. (Annexure-II).

18. REVISION OF REGULATIONS, CURRICULUM AND SYLLABI

The college may revise, amend or change the regulations, curriculum, syllabus and scheme of examinations from time to time subject to decisions/recommendations of Boards of Studies and the College Academic Council.

19. WITHHOLDING OF RESULTS

If a student has not cleared dues, if any, payable to the institution or any case of indiscipline is pending against him, the result of the student will be withheld. Also, the award of his/her degree is withheld in such cases.

20. TRANSITORY REGULATIONS

- A student, who is detained or discontinued in the semester, on readmission shall be required to do all the courses in the curriculum prescribed for the batch of students in which the student joins subsequently. However, exemption will be given to those students who have already passed courses in the earlier semester(s) he/she was originally admitted into and substitute courses are offered in place of them as approved by the Board of Studies.
- In general, after transition, there will be a fitment formula approved by the competent authority in order to balance course composition and the number of credits.

- Students admitted by transfer from other institutions shall follow transitory regulations with suitable fitment formulae approved by the competent authority.
- A student who is seeking readmission shall apply in the prescribed format within one week after the commencement of the class work. However, the readmission of a student shall be approved by the competent authority.

21. GENERAL

- Wherever the words “he”, “him”, “his”, occur in the regulations, they include “she”, “her”, “hers”.
- The academic regulations should be read as a whole for the purpose of any interpretation.
- In case of any doubt or ambiguity in the interpretation of the above rules, decision of the Chairman of the CAC is final and binding.
- The college may change or amend academic regulations or syllabi at any time subject to approval of the concern authority and the changes or amendments made shall be applicable to all students with effect from the dates notified.

22. STATUTORY DECLARATION

In case the regulations do not specify application of an appropriate rule in a unique case, the decision of the competent authority of the college shall be final.

- Ragging means doing an act which causes or is likely to cause Insult or Annoyance of Fear or Apprehension or Threat or Intimidation or outrage of modesty or Injury to a student

ABSOLUTE NO TO RAGGING

1. Ragging is prohibited as per Act 26 of A.P. Legislative Assembly, 1997.
2. Ragging entails heavy fines and/or imprisonment.
3. Ragging invokes suspension and dismissal from the College.
4. Outsiders are prohibited from entering the College and Hostel without permission.
5. All the students must carry their Identity Cards and show them when demanded
6. The Principal and the Wardens may visit Hostels and inspect the rooms any time.
