
# The institution is required to submit a Joint FDR of Rs. 15 lakhs for the above sanctioned additional course of MBA by 31<sup>st</sup> March, 2008 to the concerned Regional Office.

It may be noted that all facilities including additional built - up area and appointment of faculty should be made available before the commencement of the next academic session. Random surprise inspections would be carried out to verify facilities and if the institution is found deficient in fulfillment of norms & standards of AICTE, appropriate action would be initiated by the Council.

The institute shall take appropriate measures for prevention of ragging in any form, in the light of direction of Supreme Court of India in Writ Petition No.(C) 656/1998. In case of failure to prevent the instances of ragging by the Institutions, the Council shall take appropriate action including withdrawal of approval.

All other terms & conditions mentioned in the earlier approval letter remain unchanged.
