**4) Information and discussion on UG & PG admissions and intake quality for the A.Y.2021-22.**

Principal informed to the hon'ble members about student admission details of A.Y.2021-22 and mentioned about improvement in Intake quality when compared with previous academic years.

**Decision:** Noted and appreciated for getting quality UG students. It is suggested to put best efforts to attract quality students and improve the UG admissions in ASE, CE, ME & EEE departments. Hon'ble members approved the 50% fee concession for PG (M.Tech.) students and suggested to improve the facilities & Industry Institute Interaction to improve the PG admissions.

**5) Information and discussion on Academic Results of UG & PG for the A.Y. 2021-22 (Odd Semester).**

The Academic Results of B.Tech. (III Sem, V Sem and VII Sem), MBA & M.Tech. (III Sem) are informed to the hon'ble members of the Governing Body and also presented the details of successfully graduated UG & PG students. The % of students successfully graduated from 2017-21 batch is 88.40 and the same in the 2016-20 batch was 83.51.

The amount received from various funding agencies in the A.Y.2021-22 is Rs.54.09 Lakhs where it was Rs.41.71 Lakhs in the A.Y.2020-21

Patents published in the A.Y.2021-22 are 46 and the same in the A.Y. 2020-21 were 42.

Decision: Noted and suggested to improve the number of quality research publications, fund mobilization through consultancy and various funding agencies by submitting quality proposals. Also suggested to encourage faculty to establish linkages & collaborations to share Research Expertise and facilities.


