WHEREAS:

- A) First Party is a Higher Educational Institution named: Lakireddy Bali Reddy College of Engineering
- B) First Party & Second Party believe that collaboration and co-operation between themselves will promote more effective use of each of their resources, and provide each of them with enhanced opportunities.
- C) The Parties intent to cooperate and focus their efforts on cooperation within the areas of Skill-Based Training, Education, Placement, Industrial Visit, Expert Lecture, Student internships, R&D related activities & Consultancy.

NOW, THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES OUTLINED IN THIS MoU, THE PARTIES HERETO AGREE AS FOLLOWS:

CLAUSE 1

CO-OPERATION
